彭博引述麥樸思在香港一個媒體圓桌會議上表示，他在大約三四周前轉而看好中國股票。

麥樸思青睞中國的科技硬體公司及正在成為全球品牌的公司，例如小米(01810)。他還看好中國電動汽車製造商，稱有些公司優於特斯拉。

他又預計台灣股市仍將表現出色，並繼續看好台股。

Shatranj Capital Partners 公布，具「新興市場之父」稱號的前富蘭克林鄧普頓投資執行主席麥樸思 (Mark Mobius) 加入該行，並擔任高級顧問，將專門投資於中東地區的消費品市場。參考以往公告，麥樸思去年 6 月已加入 Shatranj Capital。

Shatranj Capital 同時宣布，委任郭子中 (William Kwok) 為亞太區首席代表及顧問，負責策劃在香港或其他亞太區主要金融城市落戶。郭子中將專責建立亞太地區的投資者關係以及發掘在亞太市場的潛在投資機會。

麥樸思指出，中東北非 (MENA) 地區正處於長期且可持續的經濟增長期，因為當地政府有遠見的領導能力和對基礎設施的巨額投資。他認為該區的社會和經濟正處於高速增長，並更有利全球化發展。

郭子中表示，有鑑於亞洲、香港和中東之間越趨頻繁的互動，有助 Shatranj Capital 促進在三地之間的合作和投資，亦令基金有更穩固的發展基礎。

曾任先思行[0595.HK]行政總裁的長子蘇智安 (Billy So)

蘇氏 1980 年成立先思行代理三星半導體，據蘇氏說當時香港電子廠大都用日本半導體，三星當時尚未出名，所以雖然價錢比較平很多電子廠都唔肯買，很辛苦才殺出一條血路，九零年代營業額已超過十億，1996 年上市，到二千年科網股泡沫時曾經每股炒到三個幾，公司市值超越三十億。

圖為蘇煜均及其曾任先思行行政總裁的長子蘇智安 (Billy So) 在股東會上合照。蘇智安是香港首家成為「獨角獸」(unicorn, 指十億美金價值以上) 的初創公司 Gogovan 的天使投資者，2017 年辭去家族生意職務全職透過其 Soul Capital 做初創投資，其網站透露亦有投資印尼最大電子商務網站 Tokopedia 及美國最受歡迎線上遊戲發展商 Epic Games 及 2021 年後逐漸建立 SoulVC 團隊進軍美國科技股等投資領域。

港風投基金疫市新領域尋寶 Soul Capital 領投本地機械人

過去曾分別投資 GOGO VAN (現稱 GOGO X)、QooApp、Storellet 等港產創科公司的風投基金 Soul Capital，去年領投了本地配送機械人初創 Rice Robotics 的 205 萬美元 (約 1600 萬港元) 種子輪融資。

Soul Capital 主席蘇智安接受專訪時指出，配送機械人在新冠疫情下發揮防疫功效，協助酒店或大型購物商場的職員把物品運往酒店房間或辦公大樓內單位，大大減輕民眾經社交接觸感染病毒的風險。其後 Rice Robotics 更成功衝出香港，目前在日本的連鎖便利店和住宅大樓亦可見到該產品蹤影。蘇智安直言，其實早於 2019 年，Soul Capital 已參與 Rice Robotics 的天使輪融資。他憶述，當時新冠疫情尚未爆發，惟相中對方的熱誠和產品設計，更看好機械人行業未來發展前景，「10 年後世界一定會多了很多機械人，總有些開發機械人的公司會成功。」

注資加密貨幣平台

除了 Rice Robotics 之外，Soul Capital 在 2020 年初也投資了港產加密貨幣衍生產品交易平台 C-Trade，至於海外風投項目方面，則有遊戲開發商 Epic Games。電玩與手機遊戲疫下迎來大爆發機會，以 Epic Games 為例，該公司剛於上周完成新一輪私募集資，金額達 10 億美元 (約 78 億港元)，眾多投資者中包括索尼集團 (Sony Group Corporation)，融資後，Epic Games 最新估值進一步漲至 287 億美元 (約 2238.6 億港元)。

At the dawn of the twentieth century, Galveston was a beacon of opportunity on the Texas Gulf Coast. Led by brothers Salvatore and Rosario at the height of Prohibition, the Maceo family answered that call and changed the Oyster City forever.
